Continue support for nutritional feeding programs in 11 neighborhood settlements. Nutrition and health have been improved through the provision of free nutritious meals to children and mothers attending 1910 meal events and serving a total of 157,584 meals. Teachers report better attendance, attention and participation by students who regularly attend the meals program.

4b (Code:) (Expenses \$ 60,060. including grants of \$ 60,060.) (Revenue \$ 0.)

Continue support for supplemental education programs for approx 1050 children in 11 neighborhood communities. Teachers in public schools report a higher achievement by those attending VAMOS classes. Computer education is also available for 150 children. Laptop computers are transported to five locations. Thirty computers are available.

4c (Code:) (Expenses \$ 17,340. including grants of \$ 17,340.) (Revenue \$ 0.)

Continue our support for medical, dental and psychological services in 11 neighborhood programs. Doctor consultations were given to 2,209 children and adults. Free medicine is provided. Payments are made to hospitals which offer treatment for chronic serious illnesses such as epilepsy, cancer, leukemia etc. Dental check-ups and treatment was provided to 650 children and 140 adults. Psychological advice and consultation regarding teenage problems, family difficulties, drugs, and sexuality were provided in group and private sessions for approx 300 mothers. Respiratory tract infections counted for most problems but parasites, urinary tract infections, hypertension were also treated.
