

THE CANCER PATIENT EMERGENCY FUND IS DESIGNED TO ASSIST WITH THE FINANCIAL NEED OF CANCER PATIENTS WHO FIND THEMSELVES IN FINANCIAL CRISIS DUE TO THEIR ILLNESS. THE EMERGENCY FUND SERVICES INCLUDE, BUT ARE NOT LIMITED TO: EMERGENCY FOOD AND SHELTER ASSISTANCE, TELEPHONE AND HEATING BILLS DURING TIME OF CRISIS, TRANSPORTATION SUPPORT IF NEEDED FOR CARE PLAN, MEDICALLY APPROPRIATE SUPPLIES NOT COVERED BY INSURANCE, MEDICATIONS, AND CHILDCARE TO ALLOW A PARENT TO GET CANCER CARE. THE PATIENT CAN ONLY USE THE FUND ONCE AND THE MAXIMUM BENEFIT PER PATIENT IS \$500.

THE PSYCHOLOGICAL SUPPORT SERVICES FUND PROVIDES COST-FREE PSYCHOLOGICAL SUPPORT TO CANCER PATIENTS. FACING THE DIAGNOSIS OF CANCER CAN BE A TIME OF FEAR, ANXIETY AND QUESTIONING. PATIENTS AND FAMILIES OFTEN DO NOT KNOW WHERE TO TURN FOR HELP. THE SERVICES PROVIDED INCLUDE: SUPPORTIVE COUNSELING BY CLINICAL PSYCHOLOGISTS KNOWLEDGEABLE OF THE ISSUES CANCER PATIENTS AND THEIR FAMILIES FACE (BOTH DURING AND AFTER TREATMENT), SUPPORT GROUPS FACILITATED BY SKILLED CLINICIANS, SEMINARS FOR SPOUSES AND CHILDREN.
