On January 31, 2009 the borrowing limit was increased to \$37,000,000

Repayment of the W/C Loan is due by September 15, 2012

Per the Working Capital Loan Agreement interest is payable to HOU monthly to the extent that ETH's cash exceeds anticipated expenses

The balance drawn on the W/C Loan was \$31,934,518 and \$28,500,000 as of December 31, 2009 and 2008, respectively

Interest paid during 2009 was \$3,042,954

The deferred interest related to the W/C Loan is recorded in other non-current liabilities and was \$1,357,774 and \$1,586,455 for the years ended December 31,2009 and 2008, respectively
