The Foundation organizes a number of academic contests each year for teams of high school students. During 2009, all of these contests were for members of chapters of the various Junior Reserve Officer Training Corps ("JROTC") programs. These contests generally consist of multiple rounds in which the students participate remotely through an Internet application. In the case of the Army JROTC Leadership Symposium and Academic Bowl, and the Air Force Academic Bowl, there is also a final round in which the top teams from the on-line competition travel to a venue for a head-to-head final round to determine the champion. The Foundation provides logistical support to participants and hosts these head-to-head rounds.

The Foundation owns the rights to certain educational content, notably the college success program "The Complete Guide to College Financing and Admissions" and the standardized test preparation game "Zero Hour Threat". These programs are made available on compact disc, digital video disc, and on the Internet.

The Foundation attempts to fulfill its purpose of assisting students in preparing for further education by providing ways for academic organizations within high schools to raise funds for their academic activities. The Foundation has packaged its educational content in a way that high school chapters of academic organizations can sell the content as a fund-raiser. By organizing this and similar fund-raising activities for chapters of JROTC and other academic organizations in high schools, it is the Foundation's intent to promote academic excellence. It is intended that a portion of the funds raised by the high school chapters will be paid as revenue to the Foundation in return for its organizing services. However, these activities were in the startup phase during 2009, so no such revenue was earned.
