HEALTH, EDUCATION AND RECREATIONAL PROGRAMSThe YMCA offers a wide variety of health, educational and instructional programs which directly further the organizational goal to improve the mind, body and spirit of individuals and families throughout the MetroWest Community In 2009 over 17,500 members and participants benefited from these programs, 1 out of 8 of whom participated with the support of YMCA financial assistance With a strong emphasis on health and wellness, safety and family strengthening, these programs include health and wellness instruction for youth through seniors including special programs focused on families,youth obesity prevention, cardiovascular and strength training, swim instruction and recreational swimming for all ages, youth sports, gymnastic instruction, preschool and youth enrichment classes, outdoor education, teen leadership development and programs specifically designed for at-risk youth Program fees are set at a level that is affordable for a major segment of the community, with financial assistance provided on a sliding scale fee basis for those who can not afford the published fee

YMCA CHILD CAREThe YMCA provided quality licensed care to 897 toddler, pre-school and school aged children in 2009, 1 out of 4 of whom received YMCA financial assistance, and 1 out of 6 of whom received State voucher or contracted slot assistance The purpose of the YMCA's Child Care Programs is to foster growth and development for children as well as their parents These educational programs help develop and support cognitive and academic growth and learning, and help kids develop moral and ethical behavior, self-esteem and leadership skills The YMCA is the largest provider of Out of School Time Care programs and a significant provider of Early Education and Care programs in the MetroWest Area In many instances, YMCA child care makes it possible for the parents of children in our programs to become and remain gainfully employed, knowing that their children are thriving in a safe, developmentally sound environment For parents who cannot afford the full fee, care is provided below cost, based on a sliding fee scale up to the limit of contributed support and funding available for subsidies 28% of the participating families receive YMCA financial assistance, with an additional 16% receiving tuition support through the state funded contract, voucher and community partnership program
