

For such exclusively charitable, educational, scientific, or literary purposes as are permitted by Section 501 (C) (3) of the Internal Revenue Code and M.G.L. c 180, Section 4 as the same may be amended from time to time including:

2a. To preserve and protect natural and aesthetically important land and wildlife habitat including fields, forests, wetlands, and trails to preserve the rural and agricultural nature of Boxford. This is accomplished by acquiring land by purchase or gift, protecting land with Conservation Restrictions, protecting trails with easements; by assisting other entities, individuals, the Town of Boxford and the Commonwealth of Massachusetts in their land and trail conservation efforts in Boxford; and through education.

2b. To promote the responsible use of trails, public and private, by non-motorized means, maintenance of these trails, and fostering communication, cooperation, and goodwill between trail users, and trail owners.

2c. To provide reasonable public access for use of trails in the Town of Boxford to which the Corporation has rights to grant such use subject to appropriate legal restriction and other rules and regulations promulgated by the Corporation.

2d. To act as sole trustee of Boxford Trails Association, the corporation's predecessor.

2e. For such other charitable, educational, scientific, or literary purposes as are permitted by Section 501 (C) (3) of the Internal Revenue Code, a M.G.L. c 180, Section 4 as the same may be amended from time to time.

The property of the corporation shall be used primarily for the benefit of the inhabitants of the Town of Boxford for the foregoing charitable purposes.

The foregoing amendment(s) will become effective when these Articles of Amendment are filed in accordance with General Laws, Chapter 180, Section 7 unless these articles specify, in accordance with the vote adopting the amendment, a later effective date not more than thirty days after such filing, in which event the amendment will become effective on such later date.
