The Civil Rights Project (the CRP) focuses on ending discrimination based on sexual orientation. More specifically, the CRP is working to bring marriage equality to all New England states, to end federal discrimination against legally married same-sex couples, and to ensure that gay and lesbian families receive the respect and recognition all families receive, with a particular emphasis on parenting issues. The CRP is also working on youth issues such as the harassment of lesbian, gay, bisexual and transgender (LGBT) youth in and out of the school setting, as well as employment and other discrimination issues.

Public Affairs and Education provides information and education to the general public, decision-makers, and individual consumers about the legal rights of LGBT people, and people living with HIV and AIDS in the six New England states. GLAD accomplishes this goal through a variety of media, from events and publications to one on one phone conversations, to podcasts and videos disseminated on the Internet. In 2009, for example, we had 85 events, including workshops on legal issues, public forums, and speaking engagements, we distributed 35,764 copies of publications on a variety of legal issues, our website had 109,428 unique visitors, we answered 2,219 calls on our Legal InfoLine, and we produced 15 videos. GLAD’s public affairs and education department is devoted to building public awareness and the dissemination of critical legal information to empower people to exercise their legal rights. Focused on enlarging circles of support for LGBT rights in all New England states, the department finds and tells the stories of LGBT people, builds organized communities of allies to prepare the ground for, and sustain, courtroom victories, and works closely with state partner organizations, providing strategy and communication consultation and support. The public affairs and education department also runs a volunteer-staffed, bilingual (English-Spanish) Legal Information Hotline, produces and continually updates over 70 publications providing practical legal information for a broad audience, as well as specialized publications for attorneys and other professionals, maintains a content-rich and up-to-date website and electronic communication network, and conducts public education efforts through the media, speaking engagements, tabling and other venues.

The Transgender Rights Project (the TRP) focuses on ending discrimination based on gender identity and expression. The TRP is working to pass legislation in three New England states that will protect people from discrimination based on gender identity and expression (three states already have those protections in the law) and is promoting administrative regulations that assist transgender people in obtaining documents consistent with their gender. The TRP also uses impact litigation to ensure that protection from discrimination based on gender identity and expression is respected and enforced. The TRP works on the federal level to pass federal legislation that will provide employment protections to LGBT people as well as working on national policy issues that affect transgender people.
