CARITAS COMMUNITIES ("CARITAS") PROVIDES AFFORDABLE HOUSING, FOCUSING ITS EFFORTS ON PREVENTING HOMELESSNESS AND STABILIZING NEIGHBORHOODS BY PROVIDING AFFORDABLE HOUSING FOR THE WORKING POOR. CARITAS ADOPTED THE LODGING HOUSE MODEL AS AN EFFICIENT AND AFFORDABLE MEANS OF PROVIDING QUALITY ACCOMMODATIONS AT AN AFFORDABLE RENT. CARITAS PRESENTLY OWNS OR MANAGES 31 BUILDINGS THROUGHOUT GREATER BOSTON WITH APPROXIMATELY 650 ROOMS. DESPITE THE DIFFICULT ECONOMY AND FUNDING CHALLENGES, CARITAS CLOSED ON THE MELROSE ROOMING HOUSE AND COMPLETED CONSTRUCTION IN 2009. ALASKA STREET IN ROXBURY NEARED COMPLETION OF 17 ROOMS AT THE END OF DECEMBER, AS DID THE SEAN BROOK HOUSE WHICH PROVIDED HOUSING FOR VETERANS IN NEW BEDFORD WHICH IS OWNED BY A NON PROFIT AFFILIATE OF CARITAS.
