The group tests and evaluates equipment for compliance with the applicable Company specifications using procedures that have been developed in cooperation with the manufacturers of the equipment and CableLabs' members (c) DOCSIS DOCSIS (Data over Cable Service Interface Specification) defines interface requirements for cable modems and cable modem termination systems (CMTS) involved in high speed data distribution over cable television system networks (d) Cable Information Services Cable Information Services provides secure industrywide data and information services to the cable companies It addresses the inherent inefficiencies of exchanging information between multiple cable companies and multiple business partners Working with cable company experts, Cable Information Services develops coordinates the preparation, review, and submission of program originated contributions to external standards bodies Creating unique national and international open technical standards for cable networks is done not only to provide for standard interconnections and operations of quality cable networks but also with the intent of attaining economic benefits for members and cable network users through competitive market forces (j) Business Services The Business Services group is developing a strategic technical roadmap to enable cable operators to serve the needs of small businesses and commercial enterprises CableLabs is working with equipment manufacturers to extend PacketCable specifications to support business telephone features and enterprise Internet protocol based telephone (IP-PBX) interconnection CableLabs is also developing a "Business Class" hybrid fiber/coax system with an emphasis on providing Metro Ethernet services over DOCSIS networks (k) Peering Registry The Peering Registry program is working to enable the exchange of VoIP traffic among cable operators, end to end, over their managed IP networks The strategic development and launch of a cable VoIP The membership of CableLabs is divided into four classes of members as follows. Class A members are operators of cable television systems in the United States with 100,000 or fewer subscribers. Class B members are operators of cable television systems in the United States with more than 100,000 subscribers. Class C members are operators of cable television systems in Canada or Mexico. Class D members are of cable television systems elsewhere in the world. The members have the power to elect certain members of the Board of Directors as its governing body, based on their number of subscribers and classes noted above. Each of the ten largest member operators located in North America, having the greatest number of subscribers as of the end of the fiscal quarter immediately preceding the election of directors, is entitled to elect one director for a total of ten top ten directors. Two directors are elected by the Class A members voting separately as a class. Five directors are elected by the Class B members voting separately as a class. Two directors are elected by the Class C members voting separately as a class. One director is elected by the Class D members voting separately as a class. Three directors are elected by Class A, Class B, Class C, and Class D members voting together as a single class. The members may also remove directors, with or without cause, by a majority of the votes cast by members of the class entitled to elect such directors of their membership class. All other rights, duties and powers are vested in the Board of Directors. General Statement 5 Part VI, Section A Governance, Management and Disclosure PART VI, SECTION A, Line 8b- There is contemporaneous written documentation for all full Board meetings and Executive Committee meetings. However, the Audit Committee generally does not contemporaneously document its meetings. The Audit Committee chair conducts most of the routine functions of the committee and informs other committee members of issues and discussion items and solicits their input, by phone or e-mail, on any material action items. General Statement 6 Part VI, Section A Governance, Management and Disclosure PART VI, SECTION A, Line 11a- The organization engages a paid preparer experienced in the preparation of Form 990 to prepare the form. Accounting department staff, the Vice President of Finance and our general counsel work closely with the paid preparer in the preparation of the return and the Vice President of Finance and general counsel review the return as prepared by the preparer. A copy of the Form 990 is then reviewed by the Audit Committee, a subcommittee of the board of directors, before it is filed. General Statement 7 Part VI, Section B Policies Part VI, Section B, Line 12c- An annual conflict of interest survey is sent to the board of directors. Annual conflict of interest e-mail requests are sent to officers and key employees. General Statement 8 Part VI, Section B Policies Part VI, Section C, Line 15 a & b- The compensation committee of CableLabs considers comparable compensation by reviewing the compensation of the CEO of another industry trade association, as well as certain senior technical positions within the organizations of the compensation committee members. The compensation committee then determines the CEO's compensation arrangement and approves the arrangement. A written employment contract is executed. The employment contract is generally for a term of 3 to 4 years. Annual salary increases for the CEO generally range 3 to 4 percent. The same process is used to determine the compensation of the COO as well. Compensation for the other officers and key employees is set by the COO together with the Vice President of Human Resources. Comprehensive salary surveys are completed every four or five years. In the intervening years, salary adjustments are based on general market trends and informal surveys of Cable Labs' member companies.
