As of August 1, 2000 under the approval of the Massachusetts Housing Finance Agency (MHFA), the ownership of Beaver Park and Beaver Gardens was transferred to Pelham Beaver Limited Partnership (the Partnership). Under this agreement, all assets, liabilities and lease agreements of the Corporation were transferred to the Partnership. The Pelham Corporation, as managing member of Pelham Beaver LLC, (the LLC), the general partner of Pelham Beaver Limited Partnership, has transferred all assets, liabilities and lease agreements of the Corporation to the Partnership in return for 6% of the profits, losses and distributions. Pelham Corporation is the sole member of Pelham Beaver LLC. Accordingly, for tax reporting purposes, Pelham Beaver LLC is considered a disregarded entity. The amounts reported on Schedule A, Part IV-A Support Schedule represent Pelham Beaver LLC's proportionate share of gross receipts from rental activities and interest income.
