

Note 1 - Nature of Activities and Significant Accounting Policies

A. NATURE OF ACTIVITIES

Havenside Corporation (a non-profit organization) operates an elderly housing assistance facility, consisting of 28 units. The Organization is supported primarily through private tenant rental income.

B. CONTRIBUTIONS

Contributions are recognized when received from the donor. Unrestricted contributions are reported as increases in unrestricted net assets in the fiscal year in which the contributions are recognized. All other donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets depending on the nature of the restrictions. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets.

C. CONTRIBUTED SERVICES

During the year ended December 31, 2009, the value of contributed services meeting the requirements for recognition in the financial statements was not material and has not been recorded.

D. ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

E. PROPERTY AND EQUIPMENT

Donations of property and equipment are recorded as support at their estimated fair value. Such donations are reported as unrestricted support unless the donor has restricted the donated asset to a specific purpose.

Assets donated with explicit restrictions regarding their use and contributions of cash that must be used to acquire property and equipment are reported as restricted support.

Absent donor stipulations regarding how long those donated assets must be maintained, the Organization reports expirations of donor restrictions when the donated or acquired assets are placed in service as instructed by the donor. The Organization reclassifies temporarily restricted net assets to unrestricted net assets at that time. Property and equipment are depreciated using the straight-line method at rates based on the following useful lives:

Buildings and improvements	20 - 40 years
Equipment	5 - 7 years

Land of \$518,343 is not being depreciated.

F. INCOME TAXES

The Organization is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code, and therefore, is not subject to Federal or State income taxes.

G. INVESTMENTS

Investments, exclusive of physical plant, are recorded at fair market value.

Note 2 - Cash Flow Information

The Company considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents. Cash and cash equivalents consist of cash on hand, checking and money market accounts.

Cash paid for interest for the years ended December 31, 2009 and 2008 was \$17,693 and \$12,808, respectively.

Note 3 - Board Designated Funds

During 2001, the Organization received a bequest in the amount of \$609,478. On November 8, 2001, the board approved a motion to restrict these funds. \$100,000 is restricted to the maintenance of property and equipment. The remainder is to be used to augment the operating account by the amount of tenant subsidies and other uses yet to be determined by the Board of Directors.
