Part III, Line 2c: Explanation of “furnishing of goods, services or facilities” to directors:

Two of the directors of Pathways Partners, George Riley and Annalee Dickson-Riley, are also the houseparents and care providers of the Pathways Partners household. This household, as a necessary part of its functioning, furnishes all its members with room, board, and basic life needs, in a fully integrated extended-family setting. In turn, the care providers furnish 24 hour-per-day care and supervision for the household and, like all members, contribute also financially to the household.

This arrangement, which seeks to eliminate as many barriers as possible, both social and financial, between the various household members, is an essential element of Lifesharing as social therapy.

Schedule A, Part II, Section C, Line 17a – the “facts-and-circumstances” test

Pathways Partners was founded to provide assistance in normal living to adults with disabilities. This is accomplished through a form of social therapy known as Lifesharing, in which families are extended to include persons with disabilities, who live together in a normal family setting, and in which each member is expected to contribute both to the functioning of the household, and to the greater community, to the extent of his or her ability. The governing board of Pathways Partners is made up of representatives of the wider community in which this extended family lives. None of the current board members are medical or social work professionals, since the intention is to minimize the institutional character of this initiative as much as possible. When Pathways Partners was founded in 1991, its members with psychiatric and/or developmental disabilities were often supported at least partially by their relatives, but with significant changes in the situations of these adults in Massachusetts, Pathways Partners became increasingly, and now exclusively, sought by those in need without either personal or family resources. Some of its members have moved into their own apartments in the community, and receive counseling and respite care. As a result Pathways Partners no longer receives any state funding for its work.

Pathways Partners has raised funds occasionally in the community through efforts such as benefit performances or sales of holiday cards, but there is, in fact, a conflict between the thrust of most fundraising (which necessarily tends to emphasize the “service” aspect of its work, and therefore puts the person with a disability in the public role of “consumer of services” or “needy client”) and Pathways Partners’ mission to strengthen the perception of all its members as valued and contributing members of their community. Pathways Partners therefore has relied in recent years primarily for support of its operations on a handful of steadfast supporters who quietly appreciate the benefit to society which its activities provide. As a result its “computation of public support percentage” in 2008 is 12%.
