We are described in our tax exemption letter of June 7, 1993, as exempt under Section 501(a) of the Tax Code as an "organization described in Section 501(c)3." We are not a private foundation because we are "an organization described in Section 509(a)3."

We support from time to time, an old church and the congregation which has been invited to use it rent free. Both the church and the congregation are represented on our Board of Directors, as are the trustees of the Trust which maintains the church and several descendants of the founder of the church.

During 2009 we received two gifts of \$15,000, from members of the Board who are also descendants of the founder. Since we had in the past several years run on the income of the endowment in repairing the church roof and the organ, we limited ourselves this year to paying the Church Mutual Insurance Company \$10,385 to protect the church.
