Career Collaborative teaches chronically low-income adults job-search skills, helps them during job-search, and provides on-going mentoring and coaching that enables 70% of them to be continuously employed for two years During 2009, 8 program-staff members, 3 interns, and more than 120 volunteers served 261 low-income adults We taught job search skills to 141 people, assisted 121 of them with job search, and mentored 148 employed adults (Clients generally receive more than one service) At the end of the year, 70% of our mentees had completed two years of continuous employment or were employed and working toward that goal
