The Adoption Center located in Ti Mache Haiti continues to provide loving care for over 35 children who may otherwise be malnourished and living on their own These children are well and happy All of the children ranging in age from a few months to 5 years old enjoy social interaction with the attentive staff three good meals each day clean clothes age appropriate toys and a large outdoor play area They participate in pre-school classes at the center when they are old enough and learn English as a second language along with a normal curriculum similar to what is offered in the US Their days are filled with love while awaiting final placement with adopting families in the United States and Canada A live-in nurse provides 24 hour medical care when needed and a Doctor is always on call Many families who have completed the adoption process over the past four years enjoy the annual celebration of culture during Haiti Days
