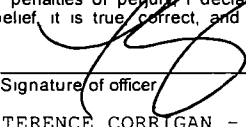

Since 1999, the CVS Caremark Charity Classic has allocated over \$14 million in charitable donations to hundreds of organizations. Over \$1.335 million was raised in 2009 alone.
