

Educational conferences, teleconferences, and seminars
The theme of WDN's Annual Conference, held in New Orleans in 2009, was "Women's Stories, Women's Leadership: Social Change in Times of Crisis." The 100 women donors who attended the conference focused on learning from the experiences of women who rose to new positions of leadership during terrible, adverse times. Through sharing stories and identifying necessary skills, participants left the conference with a better idea of the stages of leadership and activities that they might undertake to impact change in their own communities. Our numerous circles shared their stories about leadership and power in a stimulating joint presentation to give the attendees a rich view of all of the organization's work that is ongoing and contributes to the larger world. Seminars and educational sessions throughout 2009 focused on: 1) identifying and understanding structural racism and what we might do to correct it; 2) the science behind climate change, and implications and opportunities that are emerging as we attempt to tackle this multifaceted problem; (to be continued on Schedule O)

Reproductive Rights Action Circle
The Reproductive Rights Action Circle continued its collaboration with and support for the Communications Consortium Media Center's "Moving Forward" initiative to protect and expand reproductive health and rights. During 2009, this work included conducting a survey of public opinion on health care reform and reproductive rights; development of a website to disseminate these findings and educate the public about the benefits of health care reform for women; continuing briefings and distribution of educational materials to key stakeholders about effective ways to discuss reproductive and health care issues; and offering educational conference calls on related issues.

4c (Code:) (Expenses \$ **159,101** including grants of \$ **144,700**) (Revenue \$)
Gulf Coast Action Circle
The Gulf Coast Action Circle continued its ongoing work with the Twenty-First Century Foundation (21CF) during 2009. Through grantmaking and collaboration, WDN supported 21CF's Gulf Coast Organizing, Leadership, and Advocacy Initiative (GOAL), which remained focused on building the strength and resilience of Gulf Coast community organizations, so that in times of crisis, indigenous leaders of impacted communities have the necessary expertise and organizational infrastructure to swiftly respond and meet critical needs. WDN's past grants also helped fund the Steps Coalition, a multiracial alliance of progressive organizations along the Mississippi Gulf Coast which helped change the direction of post-Katrina recovery by increasing the amount of assistance available to low-income families for recovery and rebuilding efforts by almost one-third. The Circle also held educational calls on topics of interest to WDN's participants and continued to raise funds for a new production of "Swimming Upstream" in NY.

In addition, over the course of the year approximately 30 educational teleconference calls were offered to provide information and skill building for participants across a wide array of philanthropic topics. These included internet and technology-based skills, socially responsible investing, prison conditions and prison reform, immigration challenges throughout the country, human rights and water, and collaborative efforts at the state level to foster movement-building.
