ANNUAL MANDATORY ELECTION OF A THREE MEMBER
AUDIT COMMITTEE, WHO ASSUME RESPONSIBILITY FOR
THE ONCE MONTHLY AUDIT OF THE FINANCIAL RECORDS,
AS WELL AS AN ANNUAL AUDIT, AND REPORT THEIR
FINDINGS TO THE EXECUTIVE BOARD/MEMBERSHIP AT
SCHEDULED MONTHLY MEETINGS. THEY ALSO HOLD THE
AUTHORITY TO CALL FOR AN INDEPENDANT AUDIT, IF
DEEMED NECESSARY.
