Health and WellnessThe New Canaan YMCA is a community resource dedicated to promoting wellness among people of all ages through good health and exercise habits Our programs are designed to help people set realistic goals for self-improvement and disease prevention through an active lifestyle, proper nutrition and health education Members age 15 to senior may participate in a variety of cardiovascular, strength training, mind-body and nutrition programs The Y offers pre- and post- natal classes, rehabilitative class for individuals living with Parkinsons disease and other movement challenges In collaboration with Stamford Hospital the Y also offers a cardiac rehabilitation program as well as blood pressure screening In June 2009, the YMCA made available Lifeline Screening in which 70 people (members and non-members) participated In May 2009, the Y hosted a Senior Health and Fitness day, an estimated 50 to 75 people participated in health screening or obtained information at this community event about risk of common diseases including stroke, heart disease, diabetes, peripheral arterial disease, and more The YMCA strives to provide a welcoming, affirmative atmosphere where all individuals can feel comfortable and receive the support they need to improve their overall wellnesspirit, mind, and body The YMCA strives to serve everyone in the community, regardless of economic circumstances In 2009, the New Canaan YMCA awarded \$108,647 in membership assistance for more 250 individuals in financial need

ChildcareThe New Canaan YMCAs Child Development Center, accredited by NAEYC, offers Nursery School and childcare programs for children 6 weeks old through age 12 62 children were enrolled in YMCA Nursery School, 56 in full-day childcare and 54 in the Ys After-School program for children of working parents Our mission is to help maintain strong families through quality child care that helps children develop positive behavior, self-esteem, and leadership qualities The YMCA Child Development Center becomes an extension of the family while parents are at work With support from the Ys annual campaign, we maintain a childcare assistance program to help single parent and low income families remain actively employed In 2009, the YMCA provided \$57,729 in assistance for 26 children The New Canaan YMCA operates the following summer day camps Camp Mini, (ages 3-5), Camp Y-Ki, (Grades K-6), Sports Academy, (Grades 1-7), and specialized sports camps Day camp is a primary substitute for childcare during the summer Campers learn consideration for others, fairness, cooperation with others, independence and leadership Summer camp helps to build self-confidence, self-esteem and a healthy attitude More than 45 teens participated in the Ys Leader-in Training and Counselor in Training programs In 2009, an average of 345 children attended each session of Y summer camp, and the YMCA awarded \$70,211 in financial assistance to 74 campers The New Canaan YMCA also offers a Special Cares Camp program for children with a variety of special needs (e g , Down Syndrome, Autism) This program allows the children to be included in a mainstream camp by providing one-on-one staff to children with special needs at no additional cost to their families 29 campers enrolled in the Special Cares Camp participated in one of the mainstream summer camps and were given the attention and encouragement needed to grow and develop at their own pace In 2009, the New Canaan YMCA awarded approximately \$25,800 in assistance to cover the employment costs of the 29 aides

Youth DevelopmentYouth Development work at the New Canaan YMCA encompasses sports, aquatics, parent-child programs, as well as recreational programs for individuals of all ages and abilities The Ys unique approach is to emphasize character development and integrate it into the skill-learning process YMCA aquatic programs provide specific swimming and water-safety skills while promoting good health through regular exercise In 2009, an average of 490 preschool and school-age children were enrolled in the New Canaan YMCAs aquatic instruction classes each session The Y also offered specialized aquatic therapeutic programs to 42 children with special needs, including Down Syndrome, Austim, low muscle tone, sensory issues, and other physical disabilities The New Canaan YMCA offers a monthly Middle School Madness program during the school year for youth in grades five through eight The program is open to all in the community, regardless of membership status One Saturday night a month, the YMCA is open exclusively to these youth to work out in the wellness center, gym, and pool, and to partake in special events in a safe, supervised environment under the direction of Y volunteers and staff An average of 77 children (ages 10-13) attended each night in 2009 The Y-Guide & Princess program is a father-child program for children in kindergarten through third grade and their fathers The program instills closer family relationships and fosters togetherness through joint projects and outings In 2009, an average of 505 participants attended each event 837 children learned sportsmanship, teamwork, and had fun in the New Canaan YMCAs recreational sports programs, basketball, and T-Ball leagues The Ys gymnastics program challenged the physical and social development of average of 352 children in addition to 39 children in the Ys gymnastic program for children with special needs The gymnastic program emphasizes community and social skills as well as the Y core values 494 children through young adult learned leadership skills and developed their physical abilites through participation in the YMCAs three competitive aquatic teams swim, diving, and synchronized swimming The New Canaan YMCA dedicates more than 16 hours of pool time each week for Family Swim time for children and their families to enjoy informal recreational time together, as well as a comparable amount of open gym time for families In 2009, the New Canaan YMCA broadened its special needs initiative introducing 10 new programs designed for children with special needs while simultaneously welcoming children of all abilities More than 39 families participated in this growing initiative, serving more than 58 children and adults Our mission is to ensure that all who seek our services have access to them, and in 2009, the YMCA awarded \$35,150 in financial assistance toward program fees for 106 individuals

Other Program ServicesIn keeping with its mission of enriching all people in spirit, mind, and body, the New Canaan YMCA has introduced a variety of arts and humanities offerings Arts and humanities programming enriches the spirit and helps to develop childrens fundamental learning skills The YMCAs offerings include music instruction for children and adults, as well as art and science classes for preschoolers In 2009, approximately 313 were enrolled in Arts and Humanities enrichment classes The Y hosts several art exhibits throughout the year to spotlight the work of local agencies, including Arts for Healing, The Bennett Cancer Center, and the New Canaan Public Schools All in the community are welcome to visit these exhibitions free of charge The YMCA also serves as a community resource for all, regardless of their membership status with the Y The YMCA hosts four free community events each year that are open to all Healthy Kids Day, Visit with Santa, a Halloween Party, and its International Festival An average of 200 people attended each event in 2009 The YMCA also offers use of its facilities at no charge to other local nonprofits STAR (serving those with developmental disabilities), South Avenue Cottage (an assisted living facility for adults with special needs, ABC House (a residence for inner-city youth attending New Canaan public schools), A-Home (provider of safe and affordable housing for low income older adults and disabled individuals) Boy Scouts and Girl Scouts working on merit badges, among others
