Part III - Statement of Program Service Accomplishments

Cloud Forest Conservation Alliance, Inc (hereinafter "CFCA") has been formed to promote, support and sustain worldwide efforts of preservation of tropical cloud and rainforests, including reforestation, research and creating public awareness on issues related to this endeavor. Restoring and preserving the native forest protects the biodiversity for which the neotropical forests are so famous. Deforestation is causing the loss of about 100 species every day -- 4 species per hour. Preserving forest and planting trees also helps offset air pollution and helps offset climate change. The organization's focus is divided into three general areas of concern:

- (1) To preserve strategic portions of tropical forests, (this will constitute approximately 50% of the organizational activity). To target areas of the world that possess important existing natural tropical cloud forests --such as Costa Rica, with an enormous diversity of tropical trees, birds, insects and other flora and fauna-- and
 - (a) implement preservation initiatives with local government assistance including designation of endangered areas as absolute preserves, (b) land purchase (with the help of public and private contributions) to convert such sites to natural preserves that cannot be exploited, (c) propose and seek to implement sustainable development initiatives that allow indigenous peoples to live in the tropical and cloud forest without causing irreparable harm to the ecosystem.
- (2) To help rebuild deforested areas of the tropical forests as well as protect the existing forest and allow natural re-growth. We plan to accomplish this through planting a mix of native trees to turn pasture back into forest (this will constitute approximately 25% of the organizational activity)
- (3) Research and Education focused on understanding, protecting and explaining to others the tropical/cloud forest ecology. For this we expect to bring together professionals in the field including scholars, advocates and students, as well as local community residents/leaders to discuss ways of accomplishing the goals of preserving the biodiversity of tropical forests. An example of what we plan to introduce is to bring ecology students and visitors to volunteer to learn, teach and assist in the preservation initiative through planting native trees (reforestation), outreach to affected communities, and research studies such as monitoring of growth or depletion of forests. Only by experiencing it, can people truly gain an understanding how precious are our diminishing tropical forests. We will offer opportunities for volunteers and scientific researchers where they can contribute to the well-being of the planet by helping to plant trees and conduct research studies on the ecology of the areas affected, rehabilitation of pasture land, water quality, and the different species of plant, animal and bird life (this will constitute approximately 25% of the organizational activity).
