Festival classes provide beginners thru experienced dancers the opportunity to study and improve their tap technique and learn choreography from world famous tap dance legends. Tap festival classes include tap dance legends as well as local professionals. Artists travel, room and board and per diem is provided in addition to fee for services as part of the contracted servies. The tap professionals travel to Flint from locations around the country.

The Tapology festival presents a Living Legends Award Luncheon that celebrates and gives homage to the life and legacy and perseverance of the festival Honorees Contribution to the art of tap dance. the luncheon attendees include festival class participants, sponsors, family, friends and master Tap Dance legends. The 2009 Living Legend honoree was Germaine Ingram of Phildelphia, who has taught tap in workshops in the U.S. and Europe and to dance theater majors at Philadelphia University of the Arts.

Advertising consisting of several media sources and promotional videos contribute to the success of the Tapology festival and concert.
