We served as a Steering Committee member of the One New York Coalition, a group of nearly 200 organizations that fought against budget cuts. We also co-founded the 12 % and Growing Coalition, the first-ever coalition of 40 Asian American community groups to fight budget cuts and highlight the glaring lack of resources for the Asian American community.

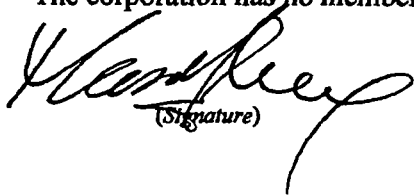

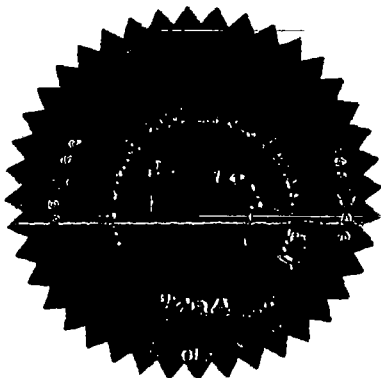
