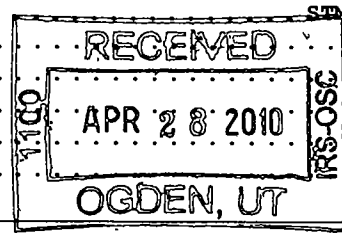

THE BYRON T BEAR FOUNDATION

2009 Annual Report

For the year 2009, the Byron T Bear foundation received a total of \$8171.00 in donations. Of that, we used \$7690.00 to provide grants for various conservation and aid efforts. These funds helped in the rescue of 42 bears among various organizations. Notably among the benefactors were Idaho Black Bear Rehab, which rehabilitated 13 cubs which have been release back to the wild with another two continuing rehabilitation with planned release in 2010. Also the International Exotic Animal Sanctuary in Boyd Texas has given sanctuary to 6 bears this year, and hosted a visit from the President of the foundation performing an onsite review of the facilities The remainder of funding was provided to Appalachian Bear Rescue, for their continuing efforts in bear rehabilitation.

We continued out education efforts and awareness programs in 2010, including distribution of numerous bear awareness brochures, ranging from Eastern Texas, Oklahoma, Kansas and South Western Missouri. The foundation was able to commandeer Byron for presentations at live events as far north as the Great Bend Renaissance Festival in Kansas, where the citizens of the state were educated to the fact that bears are within their state, and as far south as Tyler Texas in gratitude for sponsorship of the foundation.

Oklahoma efforts rounded out travels of over 7200 miles for the year, and included a stop at the Norman Medieval Fair, where the Oklahoma Department of Wildlife Conservation (ODWC) was called in to capture and relocate Byron. Byron also appeared in the eastern portion of Oklahoma with a stop visiting a festival sponsored by the Tenkiller Area Community Organization, and stops in Muskogee for the Oklahoma Renaissance Festival, along with an invite from Bill Payne to the Cookson Mountain Jubilee. These travels allowing education efforts to reach over one million people within the state.

Other efforts for the year included continued discussions and planning with the ODWC for distribution and education of Bear Aversion Kits, which the foundation plans to start distribution and education in non-lethal hazing to communities within Oklahoma which are prone to Bear encounters. In addition the Foundation sent an investigator to North West Arkansas to review claims of a problem bear in the area which was destroyed by the Arkansas Game and Fish Commission The investigation did find evidence of bear activity, however no evidence of the claims leading to the destruction of the bear were found. It is also notable that shortly after the bear was destroyed, two orphaned cubs were found in the area and were sent to Appalachian Bear Rescue for rehabilitation.

The Foundation was also delighted to support the publication of the new children's book "Bear-ly There" by Rebekah Raye by participating in a Virtual Book Tour in support of its release. We are looking forward to launching our in-school education programs sometime in 2010, and plan to including donations of the book to the schools as part of the program.
