Cluster provides programs and services that assist residents in Yonkers and Westchester County to build a better future for themselves and their communities. All of our programs seek to empower individuals, families, and communities to fulfill their dreams and potential. Mental health residential services provides housing to individuals with psychiatric disabilities. The mediation center provides mediation, arbitration, eviction prevention, restorative justice services & conflict resolution. Housing services include tenant education & organizing. Youth & family services include after-school program and summer day camp.

	Mental Health Residential Services Program. Provides housing and support services to individuals with psychiatric disabilities. Rehabilitation services include assistance with daily living skills, medication management, coordination with treatment providers, goal setting, recreational opportunities, finding appropriate housing, and securing rental assistance and all services needed related to housing. Three levels of care are provided: the congregate level - two 24-hour supervised living residences, a treatment apartment program, and the least restrictive level - supported housing.

	Westchester Mediation Center. A community dispute resolution center operated in partnership with the NYS unified court system. Cluster operates two centers with one office located in Westchester and one in Rockland. All types of mediation services are provided, including community mediation and a whole host of specialized mediation. Services in restorative justice and lemon law arbitration are also offered. Cluster operates peer mediation programs in the middle and high schools in Yonkers and provides conflict resolution consulting services throughout the county.

	Eviction Prevention Program. This program is funded through the Westchester County Department of Social Services and provides assistance to individuals facing eviction due to non-payment of rent. Cluster provides staff assistance in all of the housing courts throughout Westchester. Our eviction prevention workers reconcile agreements between landlords and tenants, secure emergency funds and prevent tenants from losing their apartments and becoming homeless.
