Since 2005, the Foundation's mission has been successfully accomplished through the increase in value of its collections from \$ 1.2 mm at the end of 2005 to \$15.6 mm at the end of 2009. This increase was largely achieved through major gifts of art such as Jean Prouv's Tropical House, Chuck Close's Arne, Hannah Wilke's S O S Starification Object Series, Robert Gober's untitled sculpture and prints, and David Smith's untitled works on paper
