The Purpose of the Stimulus Foundation is to sponsor the publication and distribution of scholarly works concerning Judaism and Christianity and to engage in other activities for the purpose of furthering scholarship in Jewish-Christian relations.

During 2009, the Foundation has published one new volume by Richard Lux, *The Jewish People, The Holy Land and the State of Israel*, and spent special efforts on the preparation of a massive volume of the complete official Church documents on Jewish-Christian Dialogue. It is now being completed by an independent formatter and designer, Celine Allen.

Also during the year, the web-master has worked to redesign the website and prepare a new and completely interactive shopping cart. This is in its final stages of preparation and should be up and running shortly.

The Stimulus Foundation has continued its interaction with the Interreligious Council of Christians and Jews in the New York area this year. Several new manuscripts are in the process of development for the coming year.

Two new board members were added, Professor Peter Pettit and Professor Yehezkel Landau at the annual meeting in the Spring.

As the costs of marketing and web promotion remain high, and plans are being made for the digital sale of books, the current finances in the downturn permit the publication of one volume per year at present.
