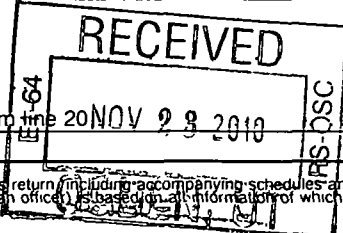

STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

The purpose of the Hiroshima Fund is to promote peace by supporting efforts in the cultural sphere to favor peace and reconciliation. The Foundation was created in 1989 following a bequest by the Swedish author Edita Morris who was married to the American author Ira Morris (1903-1972).

The fund presents awards to women and men who contribute, in a cultural field, to fostering dialogue, understanding and peace in conflict areas. The aim of the Foundation is not only to reward past contributions, but first and foremost to encourage and support continued efforts.

The Hiroshima Fund is named after Edita Morris' most famous novel, "The Flowers of Hiroshima", which describes the suffering caused by the atomic bomb. Edita and Ira Morris' son Ivan Morris (1925-1976) was a professor in Japanology and one of the first interpreters sent into Hiroshima after the explosion of the bomb.

Edita and Ira Morris founded a rest house in Hiroshima for the victims of the bomb. Both became honorary citizens of Hiroshima. Edita Morris was born in Örebro in 1902 and died in Paris in 1988.

The 2010 Edita and Ira Morris Hiroshima Prize for Peace and Culture will be awarded to the British documentary filmmaker Kim Longinotto. The award will be presented on 18 April 2010 in Stockholm. On this occasion some of Kim Longinotto's films will be shown. This is the first time the main prize has been awarded to a filmmaker.

Kim Longinotto has made a number of internationally acclaimed films which notably highlight the plight of female victims of oppression or discrimination. Among these are "Sisters in Law", a film that won the Prix Art et Essai at the Cannes Festival, which depicts the work of a judge and a State Prosecutor in Cameroon. Another is "Divorce Iranian Style" which follows the proceedings in an Iranian divorce court. "Hold Me Tight, Let Me Go" deals with an English school for excluded and emotionally scarred children. The subject of "Rough Aunties" is a group of women who care for abused and neglected children in South Africa.

The prize is given in recognition of Kim Longinotto's outstanding film work. The Foundation presents awards to women and men who contribute, in a cultural field, to fostering dialogue, understanding and peace in conflict areas.

The details of this award to Kim Longinotto in April 2010 will be provided on the 2010 US Form 990 for the Hiroshima Fund.
