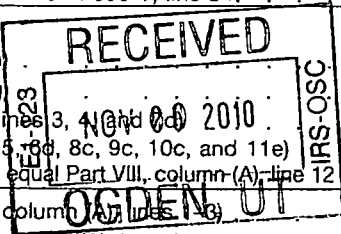

In 2009 the Fund made grants to the Institute in the amount of \$53,809,917 to support the Institute's medical research activities, including laboratory research and clinical trials.

Assistant Secretary/ Senior Investment Analyst is devoted to LICR Fund Inc. activities.

The compensation arrangements of the Vice-President/ Chief Investment Officer/ Treasurer and the Senior Investment Analyst include participation in the LGI Investment Management Incentive Compensation Plan established in concert with the Board of Directors of LICR Fund, Inc. in consultation with an independent consultant in the field. This provides for payment of incentive awards, in addition to base compensation, based on relative achievement of performance objectives.

70 percent of the incentive award is determined by a quantitative performance metric. That metric is based on performance relative to peer group performance and benchmark performance over a one and three year time horizon, with greater weight accorded the three year performance. The quantitative portion of the incentive award is reduced if the downside volatility of the LICR Fund portfolio is greater than that of the benchmark by a prescribed amount.

The qualitative performance metric, comprising up to 30% of the incentive award, is set at management's discretion subject to approval by the LICR Fund Board.

Minutes of the deliberations of all Committee and Board meetings of LICR Fund Inc. and Ludwig Institute for Cancer Research Ltd are kept and are subsequently approved by the respective Committee or Board of Directors.
