THE MISSION OF THE SEVENTH REGIMENT ARMORY CONSERVANCY, INC (THE "CONSERVANCY") IS TO RESTORE, RENOVATE AND REVITALIZE THE HISTORIC LANDMARK PARK AVENUE ARMORY AS A CONTEMPORARY ARTS INSTITUTION WHOSE PROGRAMMING USES THE VAST SPACE OF ITS DRILL HALL AND THE ARRAY OF MAGNIFICENT PERIOD ROOMS TO PRESENT VISUAL AND PERFORMING ARTS THAT RESIST THE CONFINES OF FORMAL PROSCENIUM HALLS AND WHITE-BOX GALLERIES THE CONSERVANCY IS DEDICATED TO WEAVING THE ARMORY BACK INTO THE FABRIC OF NEW YORK CITY AS A CENTER FOR CULTURE, INNOVATION AND LEARNING, FILLING A CRUCIAL NICHE IN THE CULTURAL LANDSCAPE OF THE CITY

IN 2009 THE ARMORY BEGAN SEVERAL CAPITAL PROJECTS TO MAKE THE DRILL HALL PRODUCTION READY AND ENERGY EFFICIENT, AND MAKE REPAIRS TO THE BUILDING'S EXTERIOR TO RESTORE STRUCTURAL INTEGRITY AND PREVENT LEAKS AND DAMAGE TO THE HISTORIC INTERIORS THESE PROJECTS ARE PART OF A MULTI-PHASE UNDERTAKING TO IMPROVE THE APPEARANCE AND OPERATION OF THE BUILDING, ADDRESS AREAS OF SEVERE DETERIORATION, FACILITATE ARTS PROGRAMMING, AND ACCOMODATE PUBLIC USE COLLECTION TEAMS COMPLETED SURVEYING AND CATALOGING THE ARMORY'S SIGNIFICANT COLLECTION OF FURNITURE, PAINTINGS, SCULPTURE, SILVER, AND OTHER DECORATIVE OBJECTS, AS AN INITIAL STEP FORWARD TOWARD FURTHER INTERPRETATION AND EXHIBITION ON THE ARTISTIC SIDE, 2009 SAW SIGNIFICANT DEVELOPMENT IN THE ARMORY'S ARTS PROGRAMMING, DURING WHICH IT LAUNCHED ITS FIRST SOLO EXHIBITION AND CREATED AN EDUCATIONAL PROGRAM IN MAY 2009, THE ARMORY LAUNCHED ITS FIRST ANNUAL VISUAL ARTS COMMISSION WITH ANTHROPODINO, A SITE-SPECIFIC INSTALLATION BY ARTIST ERNESTO NETO DESCRIBED AS "SPECTACULAR AND A MAGICAL DESTINATION" BY THE NEW YORK TIMES ANTHROPODINO DREW MORE THAN 31,000 PEOPLE OF ALL AGES FROM 43 STATES OVER ITS FOUR WEEK RUN THE ARMORY CONTINUED TO PRESENT ARTISTIC PROGRAMMING WITH LEADING INSTITUTIONS, WHICH RECEIVED WIDE CRITICAL ACCLAIM, AS PART OF THE 2009 LINCOLN CENTER FESTIVAL, ARIANE MNOUCHKINE'S "SUBLIME" LES EPHEMERES, AND DECLAN DONNELLAN'S "REMARKABLE" BORIS GOUNOV, WHICH, THE NEW YORK TIMES NOTED, COULD NOT HAVE BEEN STAGED IN NEW YORK UNTIL THE ARMORY BECAME AVAILABLE, IN ASSOCIATION WITH MANHATTAN SCHOOL OF MUSIC, AN EVENING OF MENDELSSOHN LED BY STUDENT CONDUCTORS, THE CULMINATION OF A WEEKLONG SEMIAR WITH KURT MASUR, A MEMORIAL EVENT FOR MERCE CUNNINGHAM, WHICH HAD DANCERS PERFORMING CONCURRENTLY ON THREE STAGES IN THE DRILL HALL, PROMPTING ONE CRITIC TO PROCLAIM THE ARMORY "AN EXTRAORDINARY PLACE", AND STIFTERS DINGE, HEINER GOEBBERS, BEAUTIFUL AND MYSTERIOUS COMBINATION OF MUSIC, THEATER, SPOKEN WORD, AND INSTALLATION ART, WHICH REQUIRED A LARGE SCALE SPACE LIKE THE ARMORY NOT ONLY FOR THE PRESENTATION BUT ALSO TO ALLOW THE AUDIENCE TO WANDER THROUGH THE COMPLEX INSTALLATION AT THE WORK'S END PRESENTED BY LINCOLN CENTER GREAT PERFORMERS, THE NEW YORK TIMES CALLED IT "MAGICAL" AND "CAPTIVATING " DURING 2009, THE ARMORY'S ARTIST IN RESIDENCE PROGRAM SUPPORTED ARTISTS SUCH AS COMPOSER MARINA ROSENFELD (SOUND), MOVING THEATER (PERFORMANCE ART), THE SHAKESPEARE SOCIETY (THEATER), AND KEMBRA PFAHLER (PERFORMANCE ART), AND ENABLED PUBLIC SHOWINGS OF THEIR WORK
