concluded in the spring We processed a number of purchase requisitions and consultant agreements for the Department of Health to enable them to implement an H1N1 mass vaccination campaign Purchases included refrigerators for vaccine storage in City elementary schools as well as hand sanitizing kits for the schools We established consulting contracts for temporary nurse services for H1N1 vaccination activities in public and private elementary schools, weekday and weekend DOHMH clinics, and some correctional facilities Additionally, we had consultant contracts for vaccine distribution and storage The original end date of the grant was July 30, 2010, but CDC extended the grant to to July 30, 2011 We are waiting for CDC to provide guidance on what specific activities PHER funds can be used for in this extension period In particular, we do not know if we will be able to use PHER funds for the upcoming 2010 fall influenza vaccine campaign Beginning in 2002, Public Health Solutions began to receive directly the PHEP grant to administer it on behalf and at the direction of DOHMH The PHEP grant provides funds for states and directly funded cities to prepare for and respond to emerging public health threats, including acts of bioterrorism, and supports regional readiness initiatives Public Health Solutions provides a full range of services to DOHMH for the PHEP grant, including recruitment and hiring, contracts administration and management, procurement of goods and services, budget management and analysis, and development and submission of all administrative and fiscal reporting documentation required by CDC We are currently in the last year of a funding cycle, we were awarded, on behalf of DOHMH, \$20 million to support a basic level of on-going activities We expect to receive guidance for the new five- year funding cycle, beginning in August 2011, early next year FORM 990, PART III, LINE 4c MIC Women's Health Services MIC Women's Health Services program provided 57,599 prenatal and family planning visits to 15,000 low-income women in six NYS licensed health centers in 2009 (one MIC Center closed at the end of 2008) Of these visits, 17,880 (31%) were made by uninsured women who paid from \$0/visit to a maximum of \$165/visit, their fee level was set on a sliding fee scale based on their income level and family size categorization on the Federal Poverty Scale MICs sites provide extensive community outreach and health education in low-income, minority communities, including education about the services and how they can be accessed MIC's clinics receive substantial state and federal grants awarded competitively to assist with covering the cost of care for family planning services provided to uninsured women FORM 990, PART III, LINE 4d all other programs WIC Provides nutrition services to women, infants, and children For the 35th year, Public Health Solutions has helped over 46,000 low-income women, infants, and children at nutritional risk obtain counseling and nutritious foods aimed at reducing or eliminating their risk exposure To this end, Public Health Solutions also provides breastfeeding education and support, physical fitness guidance, and referrals to other health and human services resources The Early Intervention Service Coordination (EISC) Early Intervention Service Coordination program serves families with children less than three years of age who are developmentally delayed, in an effort to maximize improvement and prevent further exacerbation of their conditions In addition, the program works closely with parents to help them develop effective coping mechanisms The program serves over 7,000 families each year by facilitating the eligibility determination process, identifying appropriate service providers and monitoring the timely delivery of approved services The Program's 85 multilingual Service Coordinators meet with families in their homes or at any other location convenient to them Schedule L, Part IV business transactions involving interested persons, continued As a major player in New York City's public health arena, Public Health Solutions seeks and obtains director candidates from a wide range of hospitals, universities, and other New York City area organizations that provide health services or are connected to the public health field In addition, Article 1, Sections 2 and 4 of Public Health Solutions' by-laws mandate the appointment of three local public health officials as Ex-officio Directors, the Commissioner of the New York City Department of Health and Mental Hygiene, the President of the New York City Health and Hospitals Corporation, and the Chief Medical Examiner of the City of New York Together, all of these individuals bring indispensable skills and expertise to Public Health Solutions' Board of Directors However, due to the broad scope of services Public Health Solutions provides, Public Health Solutions has business arrangements with certain public agencies and private organizations where the Ex-Officio Directors and certain other Directors are agency heads or key employees The total amount contracted with such agencies and organizations approximated \$172 million and \$164 million in 2009 and 2008, respectively Contracts with local government agencies are awarded in accordance with rigorous government procurement regulations The award of contracts to Director and Ex-officio Director-affiliated organizations comply with Public Health Solutions' purchasing procedures, Directors and Ex-officio Directors play no role in the process in either their organizational or directional capacities Management believes that Public Health Solutions is in full compliance with its comprehensive conflict of interest policy
