



AS STATED IN ITS MISSION STATEMENT THE LIBRARY'S PURPOSE IS "TO PROMOTE KNOWLEDGE, UNDERSTANDING AND APPRECIATION OF LITERATURE." IT ACCOMPLISHES THIS PROGRAM SERVICE BY PURCHASING BOOKS, MAGAZINES, NEWSPAPERS, AUDIO AND VIDEO RECORDINGS, AND PROVIDING COMPUTER TERMINALS FOR INTERNET ACCESS. THERE ARE PROGRAMS FOR CHILDREN, SUCH AS STORY TIME FOR PRE-SCHOOL CHILDREN WITH 12-20 CHILDREN PER WEEK FOR 40 WEEKS, SUMMER STORY TIMES FOR 15 CHILDREN PER WEEK AND SUMMER READING PROGRAMS FOR ELEMENTARY SCHOOL AGED CHILDREN WITH ABOUT 104 CHILDREN PARTICIPATING.
