The Children & Nature Network (C&NN) was created to encourage and support the people and organizations working to reconnect children with nature C&NN provides access to the latest news and research in the field and a peer-to-peer network of researchers, individuals, organizations, educators, business leaders, policy makers, and others dedicated to children's health and well-being C&NN builds awareness, provides access to state-of-the-art resources, develops and disseminates innovative thought leadership, supports grassroots leaders with tools and peer-to-peer networking, develops publications and educational materials, synthesizes the best available research, and encourages collaboration Since its founding in 2006, C&NN has fostered grassroots initiatives in more than 60 cities, state, provinces and nations Leaders of the initiatives reported engaging more than one million participants in nature based experiences in 2009

The Natural Leaders Network (NLN) is a flagship initiative, designed to empower 15-29 year olds to develop a worldwide youth movement to reconnect children and nature, many of whom are low-income urban youth who have transformed their lives through connections with nature and want to create those opportunities for others In 2009 the NLN created and launched the first annual Get Outside Day during C&NN's Children and Nature Awareness Month in April, which included service projects and nature-based experiences for children, youth and families, held their first national summit, developed their mission and priorities, and formed a national level core team of leaders and mentors to guide the NLN's scope of work

Regional support is based on the concepts detailed in C&NN's Community Action Guide, a publication and tool for communities, states and regions to identify stakeholders, assess the baseline, develop plans and implement those plans in order to reconnect children to nature in their everyday lives within whole communities - in school, at home, in neighborhoods, and other settings The process involves engaging a wide range of community leaders and interests, including physicians, educators, business people, landscape designers, builders and others In 2009 C&NN's work involved a continuation of pilots in three communities in Michigan, with a special emphasis on vulnerable children with little access to the benefits of experiences with the natural world to optimize their healthy development and opportunities to thrive
