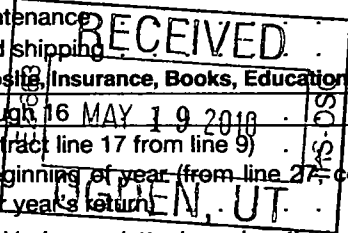


Board approves re-election of terms as follows:
