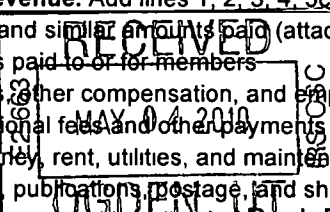

Line 20 – Other Changes in Net Assets of Fund Balance (explanation)

During 2009 the Greenwich Free Library transferred \$30,000.00 in funds back into its endowment fund. This fund is managed by the Glens Falls National Bank and the library had previously been drawing funds from it for operational expenses. Due to an increase in local support the Board of Trustees opted to cease the draw and return the money to the endowment.
