IN ADDITION, THE PHARMACY PROVIDES CONVENIENT ACCESS - WITH 24-HOUR PHONE AND INTERNET REFILL SERVICES, WEEKEND AND EVENING HOURS, AND FREE HOME DELIVERY - AND A WELCOMING AND FRIENDLY ATMOSPHERE. MORE THAN 65,000 CUSTOMERS WERE SERVED IN 2009.
