Procedures for Humanitarian aid shipments:

Humanitarian Aid donations are sent to either governmental hospitals where there is a Hemophilia Treatment Center or Registered Hemophilia Associations in the recipients countries. They are sent by International couriers such as FedEx, DHL, Aramex, etc.. The International courier requires us to provide them with specific information such as the contact name, the address and the telephone number where the shipment will be sent.

The International courier provides us with an airway bill with a tracking number to be able to track the shipment and to ensure that the shipment has been delivered and signed by the person it has been addressed to in the recipient country.

We require that the recipient countries send us an acknowledgement of receipt form that is to be signed by the person that the shipment was addressed to or their representative which specifies the product that has been sent including the brand name, the manufacturer, the lot number, the quantity of the product and the expiry date. In addition to this we ask the recipient countries to provide a detailed utilization report.
