In its 18th year, The Al Sigi Community WalkAbout involved over 1,000 volunteer walkers, who, along with generous corporate support, netted \$112,090 for Al Sigi Community of Agencies and its Members Agencies. Participating agencies were CP Rochester, Epilepsy Foundation of Rochester-Syracuse-Binghamton, Medical Motor Service, Rochester Hearing and Speech Center and Rochester Rehabilitation. Agencies raise money for specific programs and collectively to be shared by the group.

The 40th Al Sigi Sports Classic netted \$126,363 for Al Sigi and our independent agencies. Beneficiaries use the dollars for equipment and programs. Examples include the National Multiple Sclerosis Society Upstate New York Chapter used funds toward the Chapters MS Independence Fund financial assistance program. Especially in these tough economic times, funds are needed to help offset the costs of assistive technology, adaptive device purchases and environmental modifications in private homes. Rochester Rehabilitation used funding for SportsNet programs. Each year the SportsNet program provides inclusive sports, recreation and fitness programs to over 600 youth and adults with disabilities in the Rochester area, as well as 1,400 friends, family and community members. CP Rochester was helped in supporting and expanding the Community Recreation Program which provides free or low cost recreation opportunities to people with special needs. Approximately 100 people were served this past year through over 1000 program hours. The Al Sigi Sports Committee also reviews grant proposals throughout the year for funding opportunities.

The Al Sigi Foundation is charged with raising funds to advance the objectives of the Al Sigi Community of Agencies and its collaborative Member Agencies. Dollars raised are managed and allocated to one unified group of progressive Member Agencies working together to provide vital services and programs to those with disabilities and special needs. This empowered core is then able to bring greater abilities to life for others.
