The Learning Lamp engages K-12 struggling learners in individual and small group tutoring. Sessions are conducted by certified teachers using materials consistent with each student's school curriculum. The Learning Lamp works with nearly every school district in a three-county area to provide individual and school-based tutoring and credit recovery programs. In 2009, the agency served a total of 6,000 children across all programs in its core service area of Cambria and Somerset Counties.

The Learning Lamp offers high quality child care for families of all income levels. Its programs are licensed through the PA Department of Public Welfare and PA Department of Education, ensuring they meet the highest health, safety and education standards. The agency's school-year programs for young children and school-age students reach about 340 children annually. Its summer programs for preschool, school-age and middle school students serve an additional 800 children. Many of these students attend on scholarship or with assistance from state-funded child care subsidy.

The Learning Lamp provides high quality preschool experiences for children in small and rural communities in Bedford, Cambria and Somerset Counties. The preschools offer a literacy-based early learning curriculum taught by qualified and caring teachers. The agency's programs are licensed as private academic preschools through the PA Department of Education. Nearly 100 children participate in these programs, many on scholarship. In 2009, The Learning Lamp funded over \$100,000 in preschool scholarships for students attending preschool at six different locations.
