Interfaith Hospitality Network partnered with 21 local churches who provided food and shelter. The maximum guest capacity is 14. There were 48 people served through the network this year. Over seventy families have graduated successfully since the program began and 70 graduated individuals were assisted in some fashion this year by the network. Area churches took turns hosting the families one week at a time. During the day, the families who were not working or going to school, were based at the day center provided by one of the churches. Parenting classes were offered and each adult was put on a transitional plan for self-sufficiency.
