Lawrenceburg Main Street, Inc was designated to administer a new housing assistance program funded by the City of Lawrenceburg. The purpose of the program is to stimulate residential growth and revitalize the Lvee District area. Purchasers of new housing units(homes, condos, townhouses) in the target area are eligible to receive an incentive of 10% of the purchase price up to \$10,000. In 2009, 3 new home grants were given. In addition to 6 more applications were on file as of December 31,2009 awaiting completion of homes under construction.

4b (Code) (Expenses \$ 341,067 including grants of \$) (Revenue \$ 70,035)

Lawrenceburg Main Street, Inc has an active improvement and beautification program that includes grant programs for commercial and residential facade paint and improvement, as well as signs and awnings. Businesses are given 50% of the cost for paint/facade improvement up to \$1,000. Similarly a business may receive 50% up to \$1,000 for signs and awnings. Residents may receive up to \$500 for exterior paint and improvements to their homes. in 2009, 35 businesses received paint/facade grants and 45 grants were given for residences. Twenty sign and or awning grants were awarded in 2009. These programs have made a remarkable difference in the downtown.

Misc on the River is Lawrenceburg Main Street's signature series. In 2009 it included two hour concerts every Thursday evening for 14 weeks from mid June to mid September. The concerts were free and extremely well attended with attendance averaging 600 per week and some concerts as many as 1300 people. The concerts attracted people from this county and throughout Southeast Indiana, as well as neighboring Ohio and Northern Kentucky. This series has built community spirit and pride and has raised public awareness of our downtown.
