



## PART III - LINE 28

Uswa Educational Association is committed to helping the poor and needy children of Pakistan. These children are helped through schools established by Jabir Bin Hayan Trust, Islamabad, Pakistan. This organization has established over sixty schools that teach modern curriculum in an environment where no other educational opportunities are available to the children.

Uswa remitted most of the funds for the benefit of these children through the organization named above. The money has also been used for rehabilitation of many schools destroyed during the 2006 earth quake in Pakistan. Uswa also donated funds for nursing training in Kankakee, Illinois.
