The Vida y Esperanza (School of Life and Hope) provides a holistic education with a strong emphasis on the Bible and sharing the Gospel through words and actions with the students and their families in Santa Lucia Milpas Altas. The school currently has twenty teachers and full-time staff and an enrollment of 250 students in grades kindergarten through 9th grade. Seventy-five of the 250 children are sponsored through the Sowing Hope Child Sponsorship program. Our goal in the coming years is to grow the enrollment to 350 students with the addition of a new school building. Proximos Pasos (Next Steps Girls School) offers a Christ-centered educational experience to girls who are denied that opportunity by the public schools in Santa Maria de Jesus. The school offers Christian education to 125 girls from 1st to 6th grade. Classes include sewing, cooking, English, and Bible. Our holistic approach to education is Biblically based and covers the areas of academics, physical, emotional and spiritual health, family involvement, and occupational training. Future plans include the production of soy milk at the school to fortify the students' daily nutrition and provide milk for students to take home to their families. Hechos 2:8 (Acts 2:8) is a ministry in the Ixcán area of Guatemala that trains indigenous Guatemalan pastors in their native Mayan language, evangelizes children and youth, and provides for basic needs of the community through the construction of wells and latrines. Currently more than 1,400 bio-sand water filters are in use in over twelve communities. Hechos 2:8 is planning to work with the local government health agency in the coming year to manufacture 10,000 bio-sand filters for the region.
