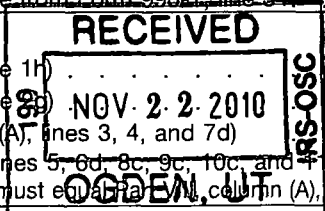

We train women from the displaced persons camps of northern Uganda in a micro-enterprise initiative that is providing them with a source of sustainable income. We currently have 100 women in the program. The project involves the creation of paper bead jewelry which Voices for Global Change, through its Paper to Pearls initiative sells in the United States and throughout the world. The women are also training in savings and cash management and are thus taught the principles of micro-finance.

Voices for Global Change raises money in support of an orphanage in Takeo, Cambodia which provides for the well-being and education of 125 children and teenagers. Our funding also provides the opportunity for Takeo orphans to go on to college or vocational schools.
