In 2009, Hagar provided trauma counseling, legal support, catch-up education, and family services to 113 girls as part of the Hagar Cambodia Aftercare programs for child victims of sexual exploitation and sex trafficking. Depending on each individual's case, some girls are reintegrated to their families of origin and others are transitioned into Family Aftercare Homes that provide high-quality, holistic care to girls rescued from these egregious forms of abuse. In 2009, Hagar USA also provided support for the construction of a new House of Smiles facility in Cambodia. Hagar Cambodia's House of Smiles program supports children with intellectual disabilities. The groundbreaking took place in the fall of 2009 and the facility is expected to be completed in the summer of 2010. Hagar USA provided support for the Hagar Cambodia Nurturing Christian commitment program. This program oversees faith-based activities, fellowship activities, and opportunities for Christian discipleship provided to Hagar Cambodia's clients and staff members. The program is an ongoing effort and will continue throughout 2010.
