**Community Building**The goal of our Community Building Program is to help immigrants and refugees participate and contribute more fully in community life We accomplish that by offering multiple opportunities for building and strengthening relationships, leadership capacity and communications - with and between organizations working with immigrants and refugees, between immigrants, refugees and other members of the community, including leaders and officials, and within the communities of immigrants and refugees During 2009 we held three major community events with over 250 participants that have deepened our success in bringing immigrants, refugees and communities of color into a civic engagement arena Our May project kick-off was held in Fargo/Moorhead where we focused on building cultural awareness of the Latino and Muslim communities - two of the fastest growing ethnic groups in the area The group of 45 men and women represented African immigrant communities, Somali, Kurdish, Bosnian, Native American Latino and Anglo communities College students, professional and governmental organizations were also represented Participants, discussed differences and common concerns, and offered positive feedback on the meeting As we evaluated the meeting outcomes, we decided to structure the next meeting to include more specific training elements and action work that would increase the involvement of community members In August, we held a second community meeting that focused on "Building a Base of Power through the Census" Native American, Bosnian, Asian, Kurdish African and Bhutanese and Anglo communities were represented and included high school and college students, nonprofit and agency staff Many were eager to participate in the Census as community leaders, and wanted to bring more information back to their communities and engage them in a more accurate and complete Census count in 2010 We soon began to broaden our partnership and began working with the Leadership Conference on Civil Rights Education Fund, As a result, we formed a "Come to My Census" coalition to do leadership training and engage a broader organizational community around the Census In October, we held very successful "Come to My Census" leadership training, covered by local media, that incorporated the work and engaged leadership of many local, regional, state and national organizations Among the 50 participants were representatives of African immigrant communities, Somali, Kurdish, Bosnian, Native American, Latino, Asian, Bhutanese and Anglo communities This training became the model for community-based civic engagement work into the next year , And finally, we held a November workshop on how to apply to be a Census field worker was attended by 25 individuals Two additional projects round our Community Building program efforts Vote By Mail and the National Rural Assembly For many rural communities and townships, voting by mail has significant advantages both in terms voter access and convenience and taxpayer savings In 2009 our Vote By Mail project staff continued to develop strategic relationships with key allies to support the expansion of vote by mail opportunities around the country Thanks to our ongoing civic engagement work, allied non-partisan groups and networks were able to leverage the advantages of mail voting to achieve more efficient and effective non-partisan voter turnout in a number of states In addition, the West Virginia Secretary of State's office consulted with MSP staff on rules for a new pilot program to allow select cities to conduct all mail municipal elections in 2011 National Rural AssemblyThe National Rural Assembly is a network of people and organizations devoted to building a stronger, more vibrant rural America for children, families, and communities The Assembly is focused on key rural policy areas such as health, education, community development, and conservation Its guiding principle is that an inclusive, prospering, and sustainable rural America improves prospects for everyone Main Street Project staff members have been active participants in all of the Rural Assembly's national and regional gatherings In 2009 MSP staff helped to create a Broadband Policy Task Force that developed a policy paper to help federal regulators gain a better understanding of the challenges facing rural communities when it comes to broadband access and affordability In 2009, MSP staff also helped organize a broadband policy workshop and a digital storytelling workshop for the Midwest Rural Assembly meeting in Sioux Falls, SD

**Media Justice**Our Media Justice program has two primary goals The first is training organizations in the art of storytelling and the use of new media tools that can help address access knowledge and empowerment issues important to rural and low-income residents and communities of color The second is to build multicultural leadership networks and coalitions have the capacity to advance media policy reform on behalf of rural communities and communities of color We began our 2009 training program by convening a multicultural advisory group representing Somali, Laotian and Native American communities to review training and materials as they were developed During the year we provided storytelling and new media trainings for over 200 individuals representing 20 organizations including Headwaters Foundation for Justice grantees, Organizing Apprenticeship Project, Twin Cities Community Voicemail, National Committee for Responsive Philanthropy (NCRP), Minnesota Center for Neighborhood Organizing and the St Paul District 7 Planning Council In particular, the training for NCRP was part of an effort on their part to better understand the connections between advocacy, organizing and civic engagement - and digital storytelling In every instance we solicited feedback and evaluation from all participants to help improve training and curriculum The other significant program goal was media policy reform We know the digital divide is a persistent and significant barrier for low-income and rural communities and communities of color to participate in the information age Early in 2009 Main Street Project worked to organize and inform members of these communities about the impending DTV transition Multilingual/multicultural organizing events and earned media formed the basis of a neighbor-to-neighbor effort that helped over 2,000 households obtain information and the necessary equipment to manage the transition from analog to digital television Main Street Project was also a catalyst for multiple local and regional networks and coalitions to come together to formulate, share and advocate for media policy reform As part of the Rural Broadband Policy Working Group we submitted comments to the National Broadband Plan, the NTIA, RUS and FCC We worked jointly with Access Humboldt and Media Mobilizing Project, to create a two-page document call "Broadband Policy-Making it Work for Everyone" which was translated into Spanish and distributed across the country We worked with People's Production House, Center for Media Justice/MAG-Net, Native Public Media, and Center for Rural Strategies, to create the framework of a Healthy Digital Ecology, and then organized and participated in three national panel discussions with different backdrops and geographic audiences including urban, rural, youth, arts and culture groups and tribal nations And finally, we formed the Minnesota Digital Justice Coalition with community-based organizations who had participated in PlaceStories trainings, and were interested in learning and working together to influence media justice policy decisions that impact their communities

**Rural Enterprise Center**The Rural Enterprise Center created an innovative, scalable model approach to farming, focused on creating economic opportunities for rural Latino families The training process builds on strengths of culture and experience and addresses challenges often tied to structural racism lack of access to land, working capital, marketing and business support infrastructure, and focused training Our work in 2009 was divided into three phases discovery, development and launch From the beginning, we knew that having community support would be essential to the program's success and we built support network of 3,000 individuals and organizations that sustain the program in many ways In Phase 1, we were able to organize and expand Northfield community gardens to 105 plots that in turn supported several Latino families gaining opportunities in market gardening We also supported community garden start-ups in Red Wing and surrounding communities And finally, we invited Latino families to experience/support poultry operations and related farm production in a process that laid the foundation for the training program development In Phase 2 we launched three poultry production units in Northfield and Cannon Falls This made it possible to engage Latino agnpreneurs and families in poultry processing training We also supported the development of grain production, processing and storage system that supplied the poultry production units We developed sustainable poultry production protocols and produced both English and Spanish language versions We also adapted CORE 4 business training for agnpreneurs and made that a central part of the curriculum And we identified land that will be made available for future centralized training unitsIn Phase 3 we worked with an economist to complete an analysis of poultry/sustainable system model We developed a partnership with Minnesota's Agriculture Utilization Research Institute (AURI) to do product analysis Finally, we set up distribution pick up sites and developed a partnership with a for profit meat distributor to begin developing a retail distribution plan
