



Note 1.

Summary of Significant Accounting Policies:

Organization

Voices Against Brain Cancer, (VABC) a New York not for profit organization whose stated goals include spreading awareness of the prevalence of brain cancer, raising funds for cure research, and disbursing the grants to qualified medical researchers in hope to help facilitate a cure for brain cancer

Basis of Accounting

The accrual basis of fund accounting is used to prepare the financial statements in accordance with generally accepted accounting principles

Financial Statement Presentation

The organization reports information regarding its financial position and activities according to three classes of net assets unrestricted net assets, temporary restricted net assets (Grants Allocated), and permanently restricted net assets

Use Of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain amounts and disclosures period Actual results could differ from these estimates

Concentration of Credit Risk

The organization maintains bank accounts at a financial institution Accounts at institutions are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of December 31, 2009 VABC did not maintain more than \$250,000 at any one financial institution.

Taxes and Exempt Status

The organization is exempt from income taxes under Section 501 (c) (3) of the Internal Revenue Code and therefore has made no provision for federal income taxes in the accompanying financial statements The organization has also been classified as an entity that is not a private foundation within the meaning of section 509 (a) of the internal Revenue Code.
