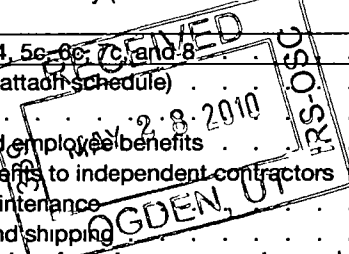

## Statement of Program Service Accomplishments

Each month, Goodpasture, Inc. hosts a multi-weekend run of a new theatrical performance. In each instance, audiences are entertained, exposed to new ideas, supportive of their own community, and given a chance to connect with artistic expressions, be they local or foreign, modern or classic. We strive to offer live music before each show and new artwork in the lobby. The following is a list of the productions that were available during 2009, and the number of people involved in each as well as the expenses, not counting general occupancy. We believe that each show is a benefit to the community and an enrichment to the city. We reach out to local artists of all mediums and nurture them despite their experience level.
