STATEMENT 8 – Form 990-PF, Part VII-B, Question 1a(5)**Transfer of assets to a disqualified person**

Question 1a(5) asks whether the Mulva Family Foundation ("Foundation") transferred any income or assets to a disqualified person during 2009. This question is answered NO for the reason that the Foundation did not make or authorize the making of any such transfer. However, in reconciling the accounts, it was discovered that Merrell Lynch (MER), the custodian of the Foundation's liquid assets, did erroneously and without authority or knowledge on the part of any director or manager of the Foundation, transfer \$60.08 to James J. Mulva, individually, on June 30, 2009. This occurred during the time the Foundation was changing the custodian of its assets from Pershing, LLC to Merrell Lynch. To transfer the assets to MER, Pershing initiated two separate transfers, one in the amount of \$2,655,556.38 on June 23, 2009 and another for \$60.08 on June 26, 2009. For some unknown reason, upon receipt of these funds, MER mistakenly issued a check dated June 30, 2009, in the amount of \$60.08, made payable to Mr. Mulva. Upon discovery, MER readily acknowledged its mistake, the \$60.08 was redeposited into the Foundation's account and MER was provided written instruction explicitly reiterating the requirement of written authorization from a duly authorized signatory on the account prior to transferring any funds or property belonging to the Foundation for which MER acts as custodian.

STATEMENT 9 – Form 990-PF, Part I, Lines 16b & 16c (supplemental)

The accounting and other professional fees set forth in Part 1, line 16b and line 16c relate to services provided by Harvey L. Black, Jr., a self-employed professional who provided these services pursuant to a professional services agreement for administrative, professional and accounting services compensated on an hourly fee basis. For the year ended December 31, 2009, a total of \$16,033 was paid pursuant to this agreement to Mr. Black as follows:
