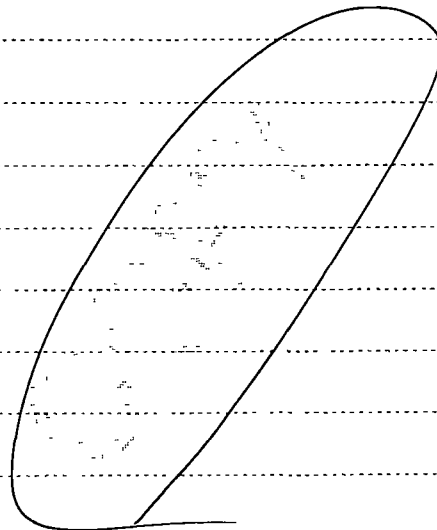

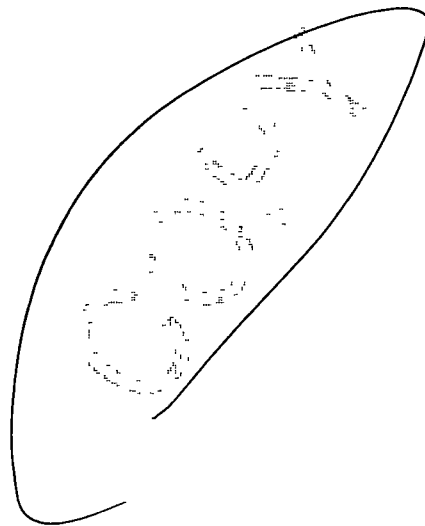


Statement 1 – Form 990-EZ, Part III – Organization's Primary Exempt Purpose
