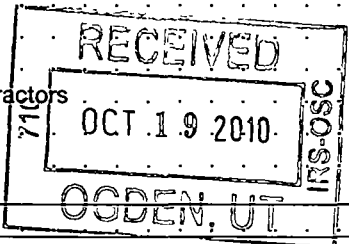



4. Educational Materials - (expenses: \$9,985, grants: \$0)

Erowid Center distributed (to members and the general public), items that help educate the public and further our educational mission such as books, information sheets, and teaching materials related to psychoactive substances.

5. Experience Report Collection - (expenses: \$11,892 grants: \$0)

Erowid Center solicited, reviewed, edited, and published first-hand reports of people's experiences with psychoactives. This provides vital information about psychoactive materials as well as aggregate data about why and how people use psychoactives, both for current factual documentation and for the historical record. At the end of 2009, we had 19,618 published reports and an additional 41,350 unpublished reports. All reports are reviewed and edited before being published. Trained volunteers perform most of the reviewing work.

6. Conferences - (expenses: \$11,096, grants: \$0)

Erowid Center conducted educational outreach in person with the general public at conferences, seminars, and festivals. In 2009, Erowid Center sent representatives to six major conferences or events and ran informational booths at four of them. These included the Horizons Conference in New York, the Harmony Festival in California, the Women's Visionary Congress in California, the Providence Tarzana Medical Center Continuing Education Program, the Symbiosis Gathering in California, and the Mycological Society of San Francisco's annual fair.

7. EcstasyData - (expenses: \$5,339, grants: \$0)

Erowid Center operated a street ecstasy testing program where individuals submitted suspected ecstasy tablets to a DEA-licensed laboratory for analysis. Its purpose is to collect, manage, review, and present laboratory pill testing results from a variety of organizations. The information is made publicly available to help harm-reduction efforts, medical personnel, researchers, and the general public. In 2009, 127 results were published online at Erowid Center's Ecstasydata.org.

8. Information Network - EEN - (expenses: \$1,756, grants: \$0)

Erowid Center continued to develop a moderated, reviewed network of both trained and self-taught experts with knowledge about psychoactive plants, chemicals, and technologies. Erowid Expert Network (EEN) members volunteer to share their expertise in order to help educate the public and improve the quality of information about this topic. The EEN facilitates making connections between those who are seeking information with experts who can help them. This furthers Erowid Center's mission by helping to improve both internal and external educational resources through increased fact-checking and review.

9. Research Improvement - (expenses: \$877, grants: \$0)

Erowid Center helped to improve scientific and anthropological information about psychoactives by promoting participation in formal studies by scientists, academics, and related organizations. We also assisted researchers in designing credible research and provided editing, reviewing and fact-checking services for academic research in areas where we have specialized knowledge.

10. Data Collection through Visitor Surveys - (expenses: \$1,094, grants: \$0)

Erowid conducted visitor surveys to collect valuable information about the use of psychoactives. In 2009, we conducted six surveys receiving a total of 53,352 responses primarily related to the use of and attitudes about nitrous oxide.

Total Other Program Services – \$42,039.
